From Hwy 101 South, take the Central San Rafael Exit and turn west onto 3rd Street. Follow 3rd street west through San Rafael and turn right onto Sir Francis Drake Blvd. Follow Sir Francis Drake Blvd. all the way through the towns of San Anselmo and Fairfax. San Geronimo Valley Community Center is approximately 7 miles west of Fairfax center. When you see the San Geronimo Valley Golf Course, keep going for another ¼ mile. Turn into the first parking lot on your right.

From Hwy 101 North, take the Central San Rafael Exit and turn west onto 3rd Street. Follow 3rd street west through San Rafael and turn right onto Sir Francis Drake Blvd. Follow Sir Francis Drake Blvd. all the way through the towns of San Anselmo and Fairfax. San Geronimo Valley Community Center is approximately 7 miles west of Fairfax center. When you see the San Geronimo Valley Golf Course, keep going for another ¼ mile.
