**From Hwy 101 South,** take the Mill Valley/Stinson Beach exit. Turn right onto Shoreline Hwy – 0.6 mile. Straight onto Almonte Boulevard. – 0.4 mile. Almonte Boulevard becomes Miller Avenue – 0.4 mile. Turn right on to Camino Alto. Go 0.1 mile to 40 Camino Alto.

**From Hwy 101 North,** take the Mill Valley/Stinson Beach exit. Straight onto Shoreline Hwy – 0.7 mile. Straight onto Almonte Boulevard. – 0.4 mile. Almonte Boulevard becomes Miller Avenue – 0.4 mile. Turn right on to Camino Alto. Go 0.1 mile to 40 Camino Alto.
