From Hwy 101 South, take the E. Blithedale Ave exit. Turn right onto E. Blithedale Ave – 0.2 mile. Continue on E. Blithedale. Stay in the left hand lane and turn left onto Camino Alto – 0.7 mile. Make a U-Turn – 121 ft. 180 Camino Alto will be on your right.

From Hwy 101 North, take the Mill Valley/Stinson Beach exit. Straight onto Shoreline Hwy – 0.7 mile. Straight onto Almonte Boulevard. – 0.4 mile. Almonte Boulevard becomes Miller Avenue – 0.4 mile. Turn right on to Camino Alto. Go 0.6 mile to 180 Camino Alto.
