From Hwy 101 South, take the Central San Rafael exit. Continue onto Hetherton Street – 0.1 mile. Turn right onto 4<sup>th</sup> Street – 289 feet. Turn left onto Tamalpais Avenue – 217 feet. Destination will be on the left.

From Hwy 101 North, take the Central San Rafael exit. Continue onto Irwin Street – 285 feet. Use the two left lanes to turn left onto 3<sup>rd</sup> Street – 0.1 mi. Turn right onto Tamalpais Avenue – 148 feet. Destination will be on the right.
