From Hwy 101 North, take the Central San Rafael exit. Continue onto Irwin Street – 285 feet. Use the two left lanes to turn left onto 3rd Street – 0.1 mi. Turn right onto Tamalpais Avenue – 148 feet. Destination will be on the right.
