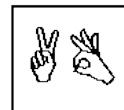
**8. 8:00pm Speaker Toril Jeltra, MD -**

Dr. Toril H. Jelter, MD, is a general practitioner and board certified pediatrician with over 30 years of experience. She was born in Oslo, Norway, moved to the United States in 1989, and in 1999 to the Bay Area. She had the life changing experience of witnessing the recovery of a young boy from autism over 3 years of treatment with an integrated and holistic approach.
