12. 8:00pm – <u>AIR POLLUTION</u> (environmental toxins) by Roberta Anthes. Presentation of a webinar on air pollution (https://earth.stanford.edu/news/new-evidence-health-impacts-wildfire-smoke#gs.ysegkr).
