#### I. Call to Order

The meeting was called to order at 4:40p.m. by Council Co-Chair Flores.

#### II. Roll Call

Roll was called by Council Support. Quorum was established with 11 of 14 Members present. CM Ferguson was absent and excused. CM Malone was absent and excused. (See February 11, 2009, "New Business".) CM Richard was absent and excused.

## III. Review and Approval of Agenda - VOTE

CM Byers made motion to approve the Agenda. CM Frazier seconded.

A voice **vote** was conducted. All were in Favor. None were Opposed. The agenda was approved unanimously.

### VII. Chair Report

Chair Flores 1.) Co-Chair Flores commented that as part of the Co-Chair Report there will be a summary of the San Francisco HIV Health Planning Services Council's monthly meeting. 2.) Co-Chair Flores reported that he spoke to Mark Molnar, one of the three San Francisco Co-Chairs about Marin hosting the San Francisco Council. Co-Chair Flores stated, "They said we are not going to have a joint Council meeting with them. They've tried over the years and it's been a bust. They couldn't get people to come to Marin. They couldn't get people to come to San Mateo. So they're not even going to make an attempt." "We are always welcome to be at their meetings". The agenda item can be removed from the Marin Care Council calendar. 3.) Co-Chair Flores ended his report with the positive comment, "...it's good to see that the [Marin Care] Council has grown."

# VIII. Membership Committee Report

Co-Chair Flores requested a recap of the Probation Policy discussion from Council Support.

M. Schieble reported, "Co-Chair Flores has asked me to brief you on the San Francisco Probation Policy." "The San Francisco Council, based on absences will suspend the voting privileges when you go on probation. After discussion, based on size of the group here, the Membership Committee didn't think that would be effective with a smaller group, that it may be difficult to make quorum and conduct business."

CM Frazier asked when the next Community Forum will be. Co-Chair Boemer responded that it was scheduled for the Fall.

# X. Division of Public Health Report.

**Budget Update:** S. Spaeth reported, "We don't have any information on the Award yet from San Francisco. All indications are that it will be flat funding."

<u>S. Spaeth</u> reported 1.) The Client Satisfaction Survey has been concluded. 78 Surveys were completed and returned. Clients will receive a Safeway Gift Card incentive for completing the survey. A list has been generated and given to all the Agencies for the distribution of the incentive. 2.) The San Francisco EMA is scheduled to conduct an audit of Marin. It is a paper report and monitoring. 3.) The Marin County budget scenarios have been completed, "...they're grim, but they're done."

Co-Chair Flores asked what the deadline was for the Client Satisfaction surveys. <u>C. Santini</u> replied that it had already passed and was February 20, 2009.

# XI. HIV/AIDS Epidemiology Report.

Co-Chair Flores introduced Deborah Gallagher, the HIV Surveillance Coordinator for Marin County and Health Department Epidemiologist.

The presentation included; an overview of the surveillance function, the California names based HIV Reporting system, disease frequency measured by incidence and prevalence. Information from the CDC was presented and answered the question, "What's New from the CDC?" Demographic information of people diagnosed with HIV infection in Marin County from 2006 – 2008 was presented. Surveillance limitations were defined and the topic of "reascertainment update" was detailed.

At the conclusion of the presentation, S. Spaeth commented, "That was the best description of data I've heard. It was very understandable."

A short question an answer period followed. The two topics of discussion were clarification on the Marin demographic data and how reporting is related to funding.
