Dear Council,

As you are aware, of course, Marin County (along with San Mateo County in our San Francisco EMA) experienced a very large reduction in our RWC Federal funding this year. The San Francisco HIV Health Services Planning Council was lucky enough to have the San Francisco Board of Supervisors and Mayor's Office offer up the entire back-fill for the needs of the City itself.

For our part in Marin county, the entire Marin HIV/AIDS CARE Council met with our Marin County Department of Health and Human Services Director, Larry Meredith, and the Marin County Administrator, Matthew Hymel, and succeeded in making our case for getting them to agree to a back-fill about 50% (or \$150,000) of the reduction amount of Marin County's budget. This was with the express understanding by the County that the Marin HIV/AIDS CARE Council would pursue all other possible resources in order to make up the other 50%, another \$150,000, for this year.

In our recent Prioritization process meeting for next year's funding (on Wednesday, July 11th), the Marin Council was told of a probable State of California funding source for the rest of our needed funding for this year. Subsequently, we Co-Chairs of the Council were told that there is a deadline of Monday, July 23rd, for getting our request/recommendation in to SF. We had no ability to post a timely notice and/or hold a meeting to discuss the issue with the entire Council, and still make that deadline.

Therefore, as Co-Chairs, we are taking this action in the Council's name. Our understanding is that the State has agreed to give the SF EMA funding, though SF itself does not want or need any of the funding, due to having been completely made whole with SF Board of Supervisors and Mayor's Office backfill, as mentioned above. Our request and recommendation is essentially that we split the available State funds between Marin and San Mateo counties.

Therefore, in order to insure that Marin County's system of care for people living with HIV and AIDS isn't decimated by the incredible and unconscionable Federal cuts this year, we are requesting and recommending that Marin receive \$150,000 from State funding for Marin's HIV/AIDS programs, for the rest of this year's needs. We would hope that the rest of the State funding could go to San Mateo County, as their needs have undoubtedly been made known.
