I. Call to Order

The meeting was called to Order at 4:45p.m. by Co-Chair Kelley.

II. Roll Call

Roll was called at 4:45p.m. Quorum was <u>not</u> present with 5 of 9 Council Members present. General announcements were made.

CM Witt arrived at 5:07p.m. and established quorum. The final meeting attendance was 6 of 9 Council Members present.

CM Cronin (AU) was absent and unexcused. CM W. Flores (AE) was absent and excused due to travel. CM Frazier (AE) was absent and excused. CM Santana (LOA) was on a leave of absence.

III. General Announcements

<u>CM Bateman</u> announced he will not be available to attend the October (on vacation) and November (schedule conflict - board meeting) Care Council meetings.

<u>CM Malone</u> announced that the Marin AIDS Project / M.A.P. will sponsor a movie in the Mill Valley Film Festival. "Themba – A Boy Called Hope" [www.mvff.com - - Sunday, October 17, 2010 at 7:00p.m.) The movie is the story of a young boy from South Africa with AIDS who has dreams of playing soccer.

Co-Chair Kelley reported that he attended Black Pride in Oakland, Labor Day Weekend.

<u>CM E.J. Flores</u> reported that she attended the 25th Anniversary of the Ryan White Act which was held on the steps of the San Francisco City Hall.

<u>CM E.J. Flores</u> reported that she was present at the San Francisco Allocation Summit meeting when the Marin Allocation was approved.

V. Co-Chair Report

VI. Division of Public Health Report

<u>C. Emerson</u> recognized Jenny Stephens for her service in Council Support. J. Stephens' work and effort over the past two years was acknowledged. She has been reassigned to a position in the Department of Health - Teen Pregnancy Program. Co-Chair Kelley awarded J. Stephens a certificate of appreciation and said, "...you made life easy... thank you for all your support."

Fern Orenstein was introduced and will serve as the new Council Support Coordinator. C. Emerson stated, "... Fern is a many year member of the HIV Prevention Committee and is the Marin County - H1N1 Flu Coordinator." F. Orenstein's resume includes work in the State Office of AIDS, STD/HIV testing, HIV counseling, HIV prevention work, and the HIV partner notification program.

- F. Orenstein and C. Emerson briefly described that the Council Support transition will include one-on-one contact with Council Members by phone. F. Orenstein will call Council Members to discuss, "...what is working, what's not working, strengths, weaknesses, and suggestions for changes or improvements."

 C. Emerson suggested, "...in lieu of a regular Council meeting, we would have a 'retreat' or open [meeting] format."
- <u>C. Emerson</u> 1.) Reported that she attended the San Francisco Allocation Summit meeting. The Marin County 2011-'12 Allocation was unanimously approved by the San Francisco HIV Health Services Planning Council. 2.) The Tom Steel Clinic is not currently accepting new Ryan White Clients. 3.) M.A.P. is the new Health Education and Risk Reduction Service Provider under the new Part B funding. 4.) The Minority AIDS Initiative program is conducting outreach. Six new Clients have been identified by Claudia Asprer and the outreach staff. 5.) The Department of Health will be conducting site visits of Service Providers. Site visits will include a review of the written protocol that details how a Client receives services.

<u>CM Malone</u> reported that the Bi-national Health Week events are the focus of the COAC. M.A.P. and the COAC will share a booth at the events which include; September 25, 2010, "Unity in the Community" – Marin City, October 7, 2010, "Valley Health Days" – San Geronimo Valley, October 9, 2010, "Canal Health and Safety Day" – San Rafael, October 16, 2010, "Green and Healthy Novato" – Novato. M.A.P.'s focus will be rapid HIV testing.

CM Malone asked, "In terms of the [Care] Council, what's the best use of the Council?" Co-Chair Kelley replied, "Recruiting new Members". Co-Chair Kelley added that Members of BBE/Black Brothers Esteem will volunteer at the Marin City event.

<u>CM Malone</u> reported that in the September 8, 2010, San Francisco Chronicle there was an article about the distribution of condoms in the San Francisco County Jails. A discussion followed about HIV prevention in jails. CM Bateman asked about the situation in the Marin County Detention Center. CM Witt suggested that the Care Council make a recommendation to the Marin Sherriff.
