| Grand Jury Response: | |
| Chair Monson stated he felt the report was accurate and that it was unfortunate the Grand Jury did not have a positive experience with the Information and Assistance unit. | |
| Copies of the recent response to the Marin Civil Grand Jury Report: "Aging in Marin – What's the Plan?" were distributed recently to the full commission. Area Agency on Aging Director Lee Pullen explained the process for the review and response. Pullen stated that the written response is not the place to elaborate on discussion and planning; rather the purpose is to answer questions as a matter of fact, either agreeing, partially disagreeing or wholly disagreeing. Then the duty of the Agency, Commission and others is to move forward with findings and recommendations as warranted. The response report was on the August 19, 2014 Board of Supervisors agenda. The Board heard this item directly from the County Administrator and voted to accept the report. Aging and Adult Services' staff were not solicited for comment on the item during the Board hearing. | |
| Commissioner Boutilier suggested getting on the Board agenda at an upcoming meeting to inform them on the broader work of the commission; | |
| Monson stated he and District 4 representative Ralph Marchese met with Supevisor Steve Kinsey recently and confirmed they were in agreement with Director Pullen and H & HS responses and that there should be a cooperative effort moving forward. There should be a "champion" from the Board of Supevisors to work with the commission. Monson also went on to state that planning is different in the eyes of the Board of Supervisors and there is no long term financial plan. There is no five year plan as a business would have at the local level. | |
