III. Review and approval of Agenda - VOTE

James made a motion to approve the draft agenda. The motion was seconded by Elaine and approved by the Council.

IV. Review and approval of Minutes - VOTE

Roy made a motion to approve the draft minutes of 1/14/15, seconded by James, approved by the Council.

V. General Announcements

- Deborah noted that Spectrum has merged with the Marin AIDS Project. Bobby interjected that the new merged entity will operate as the Spahr Center. Some clients have told us they don't want mail or email from MAP.
- Deborah requested a copy of the MSP Quality Assurance Plan.
- Cicily informed the Committee that she will ask Jennifer to explain implications of the MAP Spectrum merger at our next meeting.

VI. Co-Chair Report

 Wade reported that the San Francisco council is holding meetings about needs of Pacific Islanders and African Americans. • Cicily informed the Committee that Scott Marcum has requested a leave of absence due to conflict between our meetings and his work schedule.

VIII. Division of Public Health Report

- Cicily Emerson informed the Committee that the 5th Annual Community Picnic takes place May 16th at the Health & Wellness Campus.
- Larry Meredith retires at the end of the month.
- Sparkie Spaeth will retire at the end of June.

IX. Finalizing Allocation for 2015-2016

- Cicily reported that San Francisco told us to expect flat funding from Ryan White for 2015-16 fiscal year, which started March 1, 2015. Presented proposal to revise 2015-16 budget now. When we are notified of final grant amount, we will adjust the line items proportionately. Food Card program will expand to \$60 per month, will try to continue that level next year. Emergency funds level will be increased to \$450 for Tier One. Will discuss emergency fund at our May meeting.
- Chris reminded us the new Care Year began March 1st. We have a new category, health insurance premium and cost sharing assistance and now have some additional experience with actual spending rates. County is recommending some reallocations. We also recommend that once we are notified of our actual grant amount that we adjust all line items proportionally, based on the percentages we adopt today. See the chart below.
- Deborah made a motion to put medical case management at \$144,111 and adding the savings to Emergency funds (putting Emergency Financial Assistance at \$47,356). James seconded the motion.
- Deborah's motion, to adopt the County's 2015-16 recommended percentages with 2 changes: Medical case management at \$144,111 and Emergency Financial Assistance at \$47,356, passed (with Roy voting no, and Bobby recused himself).
- James made a motion to adopt these as percentages to be applied to award when received. Seconded by Deborah. Motion passed unanimously.
