  - 3.88 Outpatient / Ambulatory Health Care (funded through Part B)
  - 5.88 Food Bank/Home-delivered Meals (Gift Cards)
  - 6.13 Oral Health Care
  - 6.38 AIDS Pharmaceutical Assistance (local)
  - 6.38 <u>Medical Case Management (including Treatment Adherence)</u>
  - 6.75 Health Insurance Premiums and Cost Sharing (new in 2014-15)
  - 7.13 Emergency Financial Assistance
  - 8.88 <u>Medical Transportation Services</u>
  - 10.63 Home and Community based Health Care (Nurse Case Management, Attendant Care)
