## **MEETING SUMMARY**

New member Laura Eberly, Community Organizer for the YWCA San Francisco and Marin was introduced and welcomed.

Co-chair Ellie Bloch spoke about the new media campaign for the California Senior Legislature. Co-chair Sybil Boutillier Spoke about the history of last year's SB4707 property tax postponement for floating and mobile homes and also about the Administration for Community Living (ACL) and May being Older American's Month, the theme being *Blaze a Trail*. The California Senior Legislative proposals were discussed. The task force was especially interested in:

- AP 32: Geriatric Behavioral Health Positions in the California Department of Aging and in the California Department of Public Health
- AP 4: Penalties for financial institutions who fail to report elder abuse
- AP 8: Funding for senior nutrition
- AP 15: Funding for the California Senior Legislature
- AP 21: Dementia training for EMTs and hospital staff
- SP 8: Allowing hospice in Residential Care Facilities

The group then had a lively discussion regarding the Trans-Pacific Partnership and the COA advocating to abolish it as it has increased cost of drugs, created environmental issues and allows foreign corporations to sue the United States. Group came to consensus that this was a highly complicated and political issue and that a Marin County position would not carry much clout in the world of international law.
