

MARIN COUNTY COMMISSION ON AGING
Legislative Task Force Meeting
Friday, May 5, 2017

MEETING SUMMARY

Present: Ellie Bloch, Sybil Boutilier, Judy Dick, Teri Dowling, Diana López, Noreen McKeon, Joan Lubamersky & staff Michele McCabe

Summary: New member Noreen McKeon from the Redwoods was welcomed. The bill list is up to 74 that are being tracked. During the April meetings, bills were discussed and general positions taken. The 25 bills the task force wants to support were categorized as follows:

- Support 1 - Highest support, bill will be ranked and letters sent.
- Support 2 - These are the policy bills. That is the task force decided to work with five policy areas earlier this year. These bills align with the policies. Early letters may have been sent.
- Support 3 - The task force generally would support them but no formal action at this time.

The recommendation needs to get on the next Executive Committee Agenda for May 22, 2017.

Action Items:

Staff will:

1. E-mail members a spread sheet for bill ranking of Support 1 bills.
2. E-mail members an analysis and copy of SB 416, SB449 and SB481.
3. E-mail staff AB1398 and analysis so position can be taken.
4. Staff will average out rankings and report by email no later than May 18, 2017.
5. Staff will arrange a conference call on May 19, 2017 if necessary.
6. Staff will prepare materials for Teri so she can report to the Executive Committee.

Teri Dowling will make sure the recommendation gets on the COA Executive Committee Agenda.

Task Force members should:

1. Rank the Support 1 bills and return them to staff prior to May 16th.
2. Decide level of support for SB 416, SB449 and SB481 and let staff know by May 16, 2017.
3. Decide level of support for AB 1398 and let staff know by May 16, 2017.
