MEETING SUMMARY

- Co-chair Bloch welcomed the members present at the meeting.
- Legislative Aides were present but did not have formal reports this time.
- Staff reported the deadline for bill introduction is February 16, 2018.
It is too soon to decide topic areas so that was tabled until the next meeting.
- Bloch reported none of the CSL proposals have been picked up. The task force discussed the pros and cons of the top 10 CSL proposals.
- Boutilier reported there was new legislation coming regarding putting a cap on Social Security.

Proposal to Redirect the Focus of the COA – Legislative Task Force (LTF)

December 1, 2017

Passed 1-5-2018 by the Legislative Task Force

The Legislative Task Force has been reviewing all proposed legislation that pertains exclusively to Older Adults. This requires reviewing, tracking and prioritizing some 70-100 bills each legislative session. (2 years)

This proposal for 2018 would ask that the LTF pick a few major areas that it wishes to focus on and advocate for in the calendar year. The goal would be to give the LTF the opportunity to work more in depth on bills that would have the potential to have the greatest impact in Marin. This approach would also streamline the process, lessening the amount of bills Commissioners would need to read and follow and decreasing the amount of staff time required to print out, circulate and track developments on 70 – 100 bills. Staff would share with the LTF information published by CWDA, n4A and C4A on the bills these organizations support. Additionally, the Commission would support bills brought forth by CSL members.

Before choosing the subject areas, the LTF aligns with the latest AAA Area Plan to help determine what is of concern to the older adults of Marin County. The top six concerns as identified by the latest needs assessment are:

- Falls
- Memory/Cognition
- Isolation/Depression
- Financial Security
- Financial Abuse and Crime
- End of Life Planning

The LTF may also discuss policy areas with other older adult groups in the county including the California Senior Legislature, the Marin Commission on Aging (COA), Age-Friendly communities and the Aging Action Initiative. The policy areas should line up with the current year objectives and those objectives proposed for the next fiscal year. The LTF will be able to study the issues in depth and advocate more successfully. The year's activities may include the following:

- Identifying, studying and tracking state bills that pertain to the subject area
- Advocating at the local level
- Writing letters of support
- Attending and testifying at hearings in Sacramento
- Engaging the assistance of the other COA committees or the entire Commission on Aging when appropriate
- Aligning with the County of Marin's Legislative Platform and Plan
- Aligning with the Health and Human Services External Strategic Plan

This approach should be more effective, efficient, and more aligned with the concerns of the constituents that the COA represents.

GOALS AND OBJECTIVES

Goal 1: Enhance quality of life, safety, and security for older adults.

Rationale: Needs assessment findings indicate that older adults, especially those that wish to age in place, require support in maintaining and improving their security and safety, in issues ranging from financial abuse to physical, emotional, and mental well-being.
