**MEETING SUMMARY**

- Co-chair Bloch welcomed the members present at the meeting.
- Joan Lubamersky, Legislative Aide was present but did not have a formal report this time.
- Staff gave a report regarding possible bills that fall into the top six areas of concern as well as the C4A's two areas: Nutrition and Ombudsman funding.
- Members signed up to review bills in different topic areas before the next meeting. If a member was not present, they were signed up for a certain area with a partner. (See revised document following)
- Lubamersky will work with McCabe about identifying budget bills/proposals that are in those topic areas.
- Cottrell and Bloch reported on Capitol Day in Sacramento on 2/22/2018.
- Boutilier asked to include bills about long-term care facilities in the isolation/depression category. Staff reported that she is following Ombudsman bills and will see if any should be included in this list.
- Members were given suggestions about what they could do before the next meeting which include:
  1. Review possible bills to see if there are any critical enough for deep support.
  2. Sign up to track those bills.
  3. Keep track of hearings and be ready to testify if needed.
  4. Draft a support letter for Commission or Board of Supervisors for consideration.
  5. Explore to see what budget proposals are aligned with your area.
  6. Be ready to report out at our next meeting.
  7. Be ready to make recommendations for next steps regarding:
    - a. What should be the next steps in your area for advocacy this year.
    - b. Is there another COA committee or group who will partner with us on the advocacy?
