Lee will be talking to CAO more about this this afternoon. As of 9/18, Lee received the OK for the committee to send the letter. The letter was sent on 9/18. • Governor Newsom should sign both of the following bills: <ul style="list-style-type: none"> ○ SB330 which will prohibit cities and counties from creating new rules that have been documented to prevent housing production ○ AB1482 from Assemblyman David Chiu which will set limits on annual rental increases for some apartments; landlords won’t be able to raise rent more than 5% plus the regional cost of living increase or a maximum of 10% - and extends just-cause eviction protections statewide. <p>December Commission Meeting: Bloch noted we have a location for the December 5 meeting.
