6:31 PM	<p>Introductions: Brief introduction of all present. Minutes' approval and BHRS moved to later in the agenda after our guest, Wade Shannon (DEA) and Benita McLarin (HHS) speak.</p>
6:35 PM	<p>Review of Agenda / Approval of February 7, 2022 meeting Minutes - moved to end of meeting but due to time, not approved. Minutes to be reviewed at next meeting</p>
6:40 PM	<p>Presentation: Wade Shannon, DEA, Special Agent in charge of San Francisco Field Division and Northern California. Agent Shannon did an overview of focal points for the DEA on the 2020 National Drug Threat Assessment:</p> <ul style="list-style-type: none"> • Mexican cartels greatest drug trafficking threat to US • Fentanyl primarily responsible for fueling ongoing opioid crisis- 100,000 overdoses during a 12-month period ending in 4/21 (CDC) • Meth, Cocaine continues to be readily available and used steadily • RXs like Oxycontin, Adderall, and Xanax are legal but continue to be the gateway drugs leading to addiction. RXSafe Marin is one of the groups attempting to get the public to discard their unused prescriptions • COVID presented challenges to criminal organizations & their movement of drugs but still cartels had a terrible impact on The U.S. public.

	<p>Agent Shannon reported that in September a public Safety Alert was made due to the drug overdose crisis (100,000 died) and this crisis is a clear and continuous present public safety, public health and national security threat. In September the campaign of-One Pill Can Kill was launched to inform the public that Fentanyl kills. There have been record quantities of Fentanyl seized by DEA in 2021, enough to kill every American. The public is not able to discern the differences in the counterfeit pills flooding the market.</p> <p>Anti- anxiety medications and pain medications are being cut with Fentanyl which is responsible for www.dea.gov/onepill.</p>
7:10 PM	<p>Benita McLarin, HHS Director, presented her decision and recommendation to the AOD on the plan to merge the AOD with Mental Health Board in August of 2021. Ms. McLarin acknowledged the challenges and the service of the AOD Board.</p>
	<p>She cited the reasons to recommend the merger as:</p> <ul style="list-style-type: none"> • 35 out of 58 counties of California have elected to merge their AOD with Mental Health Board. Marin county will join in this direction. Steve Kaplan from San Mateo and Judy Schutzman (Humboldt County) spoke about the success of the mergers as participants in the process. Though Mr Caplan the merger takes some time. • Centralizing mental health and addiction on the same board since there is overlap between addiction & mental health. Citing the trend of comorbidities in their BHRS client population, Ms. McLarin believes the primary role of the AOD Board and the Mental Health Board is to focus on the populations primarily served by their agencies and programs. <p>There were many questions and concerns raised by Board members of this planned merger. Questions about the appeal process, defining the constituents we are to serve in Marin county and that includes those citizens <u>who are not under direct care by BHRS</u>, 83% Marin county is considered one of the healthiest counties but compared to other counties, we have higher rates of adult binge drinking, drunk driving deaths, and drug overdose rates. The death of teens continues to rise in Marin. There was a general consensus by the board to dispute the merger with appeals to BOS, County Administrator and the public. Ms. McLarin plans to present her decision to the Mental Health Board tomorrow night, March 8, 2022</p>
