<p>Legislative Aide’s Reports: Aidan Lynch, Senior Field Representative (Assemblymember Connolly):</p> <ul style="list-style-type: none"> • Assemblymember Connolly has been appointed to the following committees: <ul style="list-style-type: none"> ○ Agriculture, Utilities and Energy, Budget, Environmental Safety & Toxic Materials, and Judiciary ○ Joint Legislative Committee on Climate Change Policies, Vice- Chair ○ Budget Subcommittee 3: Climate Crisis, Resources, Energy, and Transportation ○ Select Committee on Wildfire Prevention, Chair • Highlighted Bills this committee may be interested in: <ul style="list-style-type: none"> ○ AB 319 – Establishes greater transparency with mobile home inspectors by requiring them to disclose any financial investments in mobile home parks they supervise, or any residences in the region, thus eliminating the potential for conflicts of interest that could put housing inspectors in ethically compromising situations. ○ AB 478 – Puts a cap on premium increases for homeowners insurance for seniors who live in high-risk fire zones and puts a moratorium on fire insurance cancellations for seniors in high-risk zones. ○ AB 582 – Provides a tax credit for home hardening improvements for seniors living in high-risk fire zones. ○ AB 1464 – Creates a pilot program to find a solution to the traffic congestion on the Richmond-San Rafael bridge that emphasizes the reduction of pollution. • There is not a legislative action day scheduled in Sacramento, but most Seniors, Assisted Living, and Health issue days are happening the week of April 12th-19th.
