 For the HCV grant, Ritter submitted the new scope of work for FY23/24.

two providers so far, and its working really well. Don't have to send prior authorizations anymore so that has helped a lot. We have allocated some of this grant funding to support diagnostics and labs so	

• For people who are uninsured, there are some programs to cover the medications, but it wasn't approved with one patient. Are there suggestions to get this approved in a timely manner (so patients don't lose interest)? Dr. Desruisseau says that there are patient assistance programs, such as Gilead, and generosity programs. He will email Isai some contacts that they have worked with over the years. This is for a patient that had no coverage, and the income level was above the assistance program eligibility. Below a certain threshold, they could consider a 340B provider, and all providers at MCC are 340B. might go into looking at 340 b provider, that is another option. All providers are 340b at mcc.

Bill Remak (California Hepatitis C Taskforce)

- Submitted abstract to Association of Liver Disease, coming out in November, will find out if the submission has been approved.
- Working on applications and grants and bringing on another board member.
- Starting to register in other states. Expanding our partnership throughout the state, going very well. Would like to see more funding from state, HHS, HRSA, and other agencies with regard to viral hepatitis.
- CA HCV task force is taking interns contact Bill if your agency wants interns to help out. The intern can support the HCV coalition but work with a program within the taskforce.

HHS

- We will fund all three agencies at \$35,000 each for FY23/24. Working with each agency to update SOW and budget. We won't find out about funding beyond July 2024 until early next year.
- State of CA was providing grants for point of care tests for HCV grants, if in need of tests, Rachel McClean has them at her office.
- We are working with Marin County Cooperation Team and Canal Alliance to launch an STI home-based testing pilot project in July. The test kit includes testing for HIV, HCV, Syphilis, and diabetes.

Cat Condon (BHRS)

- We provide direct services or contract with CBOs to provide substance use treatment services. The services are for Marin low income or Medi-Cal beneficiaries. Most of the services are contracted out.
- When providers are doing their initial screening and assessment, they will ask a variety of health questions but are not doing any screenings. MTC is one of the largest treatment providers.

•	All providers meet together once a month, the HCV team can present to the treatment providers at this meeting to increase awareness and provide referral resources for treatment. Providers include MTC, Helen Vine, BACR, Ritter, CenterPoint, some out of county providers in the East Bay and SF who join via Zoom, and the Recovery Coaches. There are Marin services for men, for sober living and outpatient program in Spanish. There is a health questionnaire that is self-report – can run a report.	Cat can share the report regarding self-reported HCV.

•	Linda and Dr. Desruisseau have completed some detailing sessions with MCC. They have scheduled with Ritter at the end of June for the new hires – the training will be for all their staff members. We presented to the Forensic Mental Health team at the Jail to inform them about the HCV testing efforts.	
•	Working on getting point persons at One Medical and Carbon Health.	
•	It would be good to connect with Marin Treatment Center. They have	
	administration details they needed to work out, and MTC is going	
	through a change in Director.	
•	Dr. Thompson has already provided the HCV training at MCC's provider	
	meeting.	
IV.	HCV Education and Testing at Marin County Jail	
•	Goal: 100 inmates tested at MCJ in 2023 – so far have conducted 35	
	tests and the flagging process started a month ago.	
•	We have had an uptick in screenings since the "opt-out for those with	
	identified risk" has been implemented. Booking nurse can flag the	
	charts and with the HCV education sessions, inmates can also submit	
	sick call slip to request screening. Also met with Forensic Mental Health	
	staff so they are aware of the efforts and can flag the charts as well.	
•	There is a learning curve in terms of how long we wait to screen an	
	inmate when they enter, waiting a week or so is better, since they	
	don't know its coming. Staff has been helpful.

•	Clients are not aware that HCV treatment takes 8-12 weeks, so that is	
	why Spahr wants to provide a handout explaining the treatment process and treatment plans.	
•	There are patient stories on YouTube and a number of Hepatology	
	departments and nonprofits have on their website – many success	
	stories about treatment, people from all walks of life, the treatment	
	and results they see in themselves. These are helpful for people to	
	watch, and it is calming for someone who is nervous about their
