

## Mental Health Services

Marin County Mental Health and Substance Use Services provides a complete range of mental health services for children, adults, and older adults.

Our multilingual, culturally competent staff provides on-site treatment for acute and chronic mental disorders, and other disabilities that occur concurrently with mental disorders. In some instances, we provide clients with referrals to private practitioners and agencies. We work closely with county educational, medical, criminal justice, and social service systems to make sure every client receives comprehensive care.

All residents of Marin County are eligible for mental health services. Fees are assessed on a sliding scale, based on a person's ability to pay.

## Public Health Services

The vision of Community Health and Prevention Services is “healthy people in healthy communities.” This vision is achieved by addressing the underlying community factors that impact health, such as ensuring safe places to live, work, and play, access to health care services, healthy foods, and the community resources needed to maintain well-being and quality of life.


Community Health and Prevention is committed to working in partnership with the community to build on and learn from the strengths and diversity to prevent and reduce chronic diseases.

## About Our Center

The West Marin Human Services Center was established in 1972 in response to the needs of rural West Marin community. The Center uses an integrated model of providing culturally competent social services and offers a variety of programs to residents:

- ◆ Economic Assistance
- ◆ Adult Social Services
- ◆ Child Protective Services
- ◆ Mental Health Services
- ◆ Public Health Nursing
- ◆ In Home Supportive Services
- ◆ Information and Referral Services

The Center also partners with the West Marin community to provide space and support for the following programs:

- ◆ Women, Infants and Children (WIC)
- ◆ Self-Help Groups
- ◆ Senior Services Collaborative
- ◆ District Attorney - Victims of Crime Program

## Economic Benefit Services

### CalFresh (formerly Food Stamps)

The CalFresh Program helps people with little or no income buy nutritious food. CalFresh benefits are not cash. They come on an electronic benefit transfer (EBT) card that you use like a bank card to buy food.

### County Medical Services Program (CMSP)

CMSP can help with medical and dental costs for people age 21-64 that meet eligibility requirements and are not eligible for Medi-Cal.

### CalWorks

CalWorks (California Work Opportunities and Responsibility for Kids) Employment Services provides comprehensive case management services to recipients of TANF (Temporary Assistance to Needy Families). Services may include vocational assessment, education assistance, mental health, substance abuse or domestic abuse evaluations. The goal of the program is to facilitate clients reaching family self-sufficiency.

### Medi-Cal

Medi-Cal is a public health insurance program that provides medical coverage for low-income individuals that are disabled, 65 years of age or older, those under 21 years of age, and the parents of children deprived of parental support due to unemployment, absence, disability, or death of a parent. Eligibility for the program depends on residency, citizenship or immigration status, age, income, resources/assets, family composition and other factors.

## Social Services

### Adult and Aging Services

Anyone aged 18 to 64 who, because of their mental or physical disability is unable to effectively protect themselves against abuse or neglect, or anyone age of 65 or older, who is suspected of being abused or neglected, is eligible for APS without regard to income.

If you suspect that an elderly or dependent adult is being abused or neglected, call Marin County Adult Protective Services, 24 hours/day, at 473-2774. With the goal of enabling the person to live as safely and independently as possible, the APS social worker will coordinate services with available family, supportive friends and community resources.

### Children and Family Services

Children and Family Services (CFS) Emergency Response is available 24 hours a day, 7 days a week, 365 days a year to receive and assess allegations of child abuse, neglect or exploitation. Each report is assessed to determine the level of response/information required to protect the child(ren).

Any incident of alleged or suspected child abuse, or a reasonable suspicion of abuse, which comes to your attention, should immediately be reported. All reports should be made as soon as possible by telephone to (415) 473-7153 and you may download Suspected Child Abuse Report Form at
